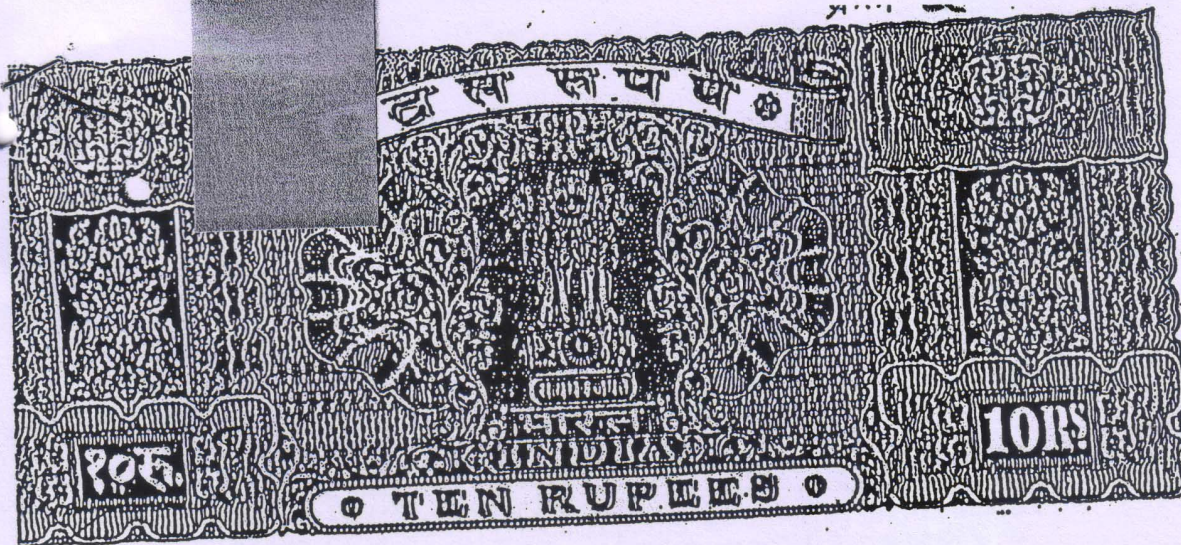

THE BETHANY EDUCATIONAL SOCIETY, MANGALORE.

MEMORANDUM OF ASSOCIATION.

1. The Institution shall be called "THE BETHANY EDUCATIONAL SOCIETY, MANGALORE" hereinafter called "The Society".

2. The objects for which the Society is established are:-

(a) To promote literature, science and general culture; diffusion of knowledge and friendship; spread of works of charity; development of trade by agriculture and horticulture; to establish, support, manage, or conduct schools, colleges or such other institutions and to take over the Management of other schools or institutions as may be decided by the Society.

(b) To manage and maintain the following, among other institutions with the one or the other of the above mentioned ends in view:-

- (e) To deal with all the monies of the Society and to invest them upon such securities and in such manner as may from time to time be determined by the Society including shares of joint stock companies or banks, without however personal profit or monetary gain to the members.
- (f) To acquire, purchase or sell any moveable or immovable properties, to acquire by purchase or otherwise any rights on immovable properties for all or any of the purposes mentioned above.
- (g) To pay either in cash or otherwise for any property or rights acquired and service rendered to the Society.
- (h) To borrow, raise loans on debentures or D.P. Notes or otherwise procure moneys on the security of moveable, immovable or other assets of the Society or otherwise for carrying on all or any of the objects of the Society.
- (i) To do all or any of the above things, transactions or matters to do all such other things as are incidental or conducive to the attainment of the above objects or any of them.
